

**PhillipMart Announces Pre-IPO Share Price of  
 China Tower Corporation Limited (Stock code: 00788)**

(Hong Kong – 7 Aug 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China Tower Corporation Limited (China Tower)**; stock code: 00788) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Tower** on PhillipMart were HK\$1.28 & HK\$1.22. The price closed at HK\$1.25 per share, 0.79% lower than its offer price of HK\$1.26. The price opened at HK\$1.26, with the most actively traded price of HK\$1.24 per share, and a turnover of 16,550,000 shares. The total trading volume reached 53,366,000 shares with **total turnover of HK\$66,093,600.00**. The final price of **China Tower**, to debut trading on 8 Aug. It has been fixed at HK\$1.26 per share.
