

**PhillipMart Announces Pre-IPO Share Price of  
 ETERNITY TECHNOLOGY HOLDINGS LIMITED (Stock code: 1725)**

(Hong Kong – 15 Aug 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of ETERNITY TECHNOLOGY HOLDINGS LIMITED (“ETERNITY TECH”; stock code: 1725) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for ETERNITY TECH on PhillipMart were HK\$1.93 and HK\$1.51. The price closed at HK\$1.57 per share, 10.29% higher than its offer price of HK\$1.57. The price opened at HK\$1.93, with the most actively traded price of HK\$1.63 per share, and a turnover of 900,000 shares. The total trading volume reached 9,900,000 shares with **total turnover of \$15,942,600**. The final price of ETERNITY TECH, to debut trading tomorrow has been fixed at HK\$1.57 per share.
