

## PhillipMart Announces Pre-IPO Share Price of Golden Ponder Holdings Limited (Stock code: 1783)

(Hong Kong – 21 Aug 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Golden Ponder Holdings Limited ("Golden Ponder"; stock code: 1783) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Golden Ponder on PhillipMart were HK\$0.62 and HK\$0.485. The price closed at HK\$0.49 per share, 10.91% lower than its offer price of HK\$0.55. The price opened at HK\$0.6, with the most actively traded price of HK\$0.5 per share, and a turnover of 4,340,000 shares. The total trading volume reached 21,610,000 shares with **total turnover of \$11,452,900**. The final price of Golden Ponder, to debut trading tomorrow has been fixed at HK\$0.55 per share.
