

**PhillipMart Announces Pre-IPO Share Price of  
 DLC Asia Limited (Stock code: 8210)**

(Hong Kong – 24 Aug 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of DLC Asia Limited (“DLC Asia”; stock code: 8210) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for DLC Asia on PhillipMart were HK\$0.265 and HK\$0.241. The price closed at HK\$0.248 per share, 2.75% lower than its offer price of HK\$0.255. The price opened at HK\$0.265, with the most actively traded price of HK\$0.246 per share, and a turnover of 1,970,000 shares. The total trading volume reached 8,910,000shares with **total turnover of HK\$2,196,890**. The final price of DLC Asia, to debut trading next Monday. It has been fixed at HK\$0.255 per share.
