

PhillipMart Announces Pre-IPO Share Price of Wan Leader International Limited (Stock code: 8482)

(Hong Kong – 4 Sep 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Wan Leader International Limited ("Wan Leader"; stock code: 8482) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Wan Leader on PhillipMart were HK\$0.285 and HK\$0.255. The price closed at HK\$0.27 per share, 1.8% lower than its offer price of HK\$0.275. The price opened at HK\$0.265, with the most actively traded price of HK\$0.265 per share, and a turnover of 4,320,000 shares. The total trading volume reached 16,900,000 shares with **total turnover of HK\$4,582,800**. The final price of Wan Leader, to debut trading tomorrow has been fixed at HK\$0.275 per share.
