

**PhillipMart Announces Pre-IPO Share Price of  
 Eggriculture Foods Ltd. (Stock code: 8609)**

(Hong Kong – 6 Sep 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Eggriculture Foods Ltd. (“Eggriculture”; stock code: 8609) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Eggriculture on PhillipMart were HK\$0.485 and HK\$0.455. The price closed at HK\$0.465 per share, 7% lower than its offer price of HK\$0.5. The price opened at HK\$0.455, with the most actively traded price of HK\$0.465 per share, and a turnover of 1,340,000 shares. The total trading volume reached 3,390,000shares with **total turnover of HK\$1,596,700**. The final price of Eggriculture, to debut trading tomorrow has been fixed at HK\$0.5 per share.
