

**PhillipMart Announces Pre-IPO Share Price of
 AB Builders Group Limited (Stock code: 1615)**

(Hong Kong – 7 Sep 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of AB Builders Group Limited (“AB Builders”; stock code: 1615) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for AB Builders on PhillipMart were HK\$0.69 and HK\$0.58. The price closed at HK\$0.67 per share. It’s same as offer price. The price opened at HK\$0.6, with the most actively traded price of HK\$0.67 per share, and a turnover of 2,900,000 shares. The total trading volume reached 10,615,000shares with **total turnover of HK\$6,909,100**. The final price of AB Builders, to debut trading on 10 Sep. It has been fixed at HK\$0.67 per share.
