

## PhillipMart Announces Pre-IPO Share Price of Hua Medicine (Stock code: 2552)

(Hong Kong – 13 Sep 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Hua Medicine ("Hua Medicine"; stock code: 2552) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hua Medicine on PhillipMart were HK\$8.2 and HK\$7.65. The price closed at HK\$8.2 per share, 0.97% lower than its offer price of HK\$8.28. The price opened at HK\$7.65, with the most actively traded price of HK\$7.9 per share, and a turnover of 52,500 shares. The total trading volume reached 154,000shares with **total turnover of HK\$1,214,790**. The final price of Hua Medicine, to debut trading tomorrow has been fixed at HK\$8.28 per share.
