

**PhillipMart Announces Pre-IPO Share Price of
 WAC Holdings Limited (Stock code: 8619)**

(Hong Kong – 14 Sep 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of WAC Holdings Limited (“WAC Holdings”; stock code: 8619) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for WAC Holdings on PhillipMart were HK\$0.34 and HK\$0.24. The price closed at HK\$0.335 per share, 67.5% higher than its offer price of HK\$0.2. The price opened at HK\$0.24, with the most actively traded price of HK\$0.31 per share, and a turnover of 2,720,000 shares. The total trading volume reached 11,610,000 shares with **total turnover of HK\$3,476,920**. The final price of WAC Holdings, to debut trading at 17 Sep. It has been fixed at HK\$0.2 per share.
