

PhillipMart Announces Pre-IPO Share Price of Haidilao International Holding Ltd. (Stock code: 6862)

(Hong Kong – 26 Sep 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Haidilao International Holding Ltd. ("Haidilao"; stock code: 6862) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Haidilao on PhillipMart were HK\$19.5 and HK\$18. The price closed at HK\$19.26 per share, 8.2% higer than its offer price of HK\$17.8. The price opened at HK\$18, with the most actively traded price of HK\$19 per share, and a turnover of 778,000 shares. The total trading volume reached 4,090,000shares with **total turnover of HK\$78,412,920**. The final price of Haidilao, to debut trading at 26 Sep. It has been fixed at HK\$17.8 per share.
