

PhillipMart Announces Pre-IPO Share Price of TradeGo FinTech Limited (Stock code: 8017)

(Hong Kong – 27 Sep 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of TradeGo FinTech Limited ("TradeGo"; stock code: 8017) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for TradeGo on PhillipMart were HK\$0.73 and HK\$0.65. The price closed at HK\$0.66 per share, 3.13% higher than its offer price of HK\$0.64. The price opened at HK\$0.7, with the most actively traded price of HK\$0.67 per share, and a turnover of 4,268,000 shares. The total trading volume reached 19,032,000shares with **total turnover of HK\$12,810,680**. The final price of TradeGo, to debut trading tomorrow has been fixed at HK\$0.64 per share.
