

PhillipMart Announces Pre-IPO Share Price of Sun Cheong Creative Development Holdings Limited (Stock code: 1781)

(Hong Kong – 3 Oct 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Sun Cheong Creative Development Holdings Limited ("SC Creative Dev"; stock code: 1781) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SC Creative Dev on PhillipMart were HK\$1.55 and HK\$1.15. The price closed at HK\$1.18 per share, 7.27% higher than its offer price of HK\$1.1. The price opened at HK\$1.15, with the most actively traded price of HK\$1.26 per share, and a turnover of 600,000 shares. The total trading volume reached 5,246,000shares with **total turnover of HK\$6,838,460.00**. The final price of SC Creative Dev, to debut trading tomorrow has been fixed at HK\$1.1 per share.
