

## PhillipMart Announces Pre-IPO Share Price of Ganfeng Lithium Co., Ltd. (Stock code: 01772)

(Hong Kong – 10 Oct 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Ganfeng Lithium Co., Ltd. (“Ganfeng Lithium”; stock code: 01772) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Ganfeng Lithium on PhillipMart were HK\$16.4 and HK\$16. The price closed at HK\$16.06 per share, 2.67% lower than its offer price of HK\$16.5. The price opened at HK\$16, with the most actively traded price of HK\$16.1 per share, and a turnover of 469,800 shares. The total trading volume reached 469,800shares with **total turnover of HK\$7,546,596**. The final price of Ganfeng Lithium, to debut trading tomorrow has been fixed at HK\$16.5 per share.
