

## PhillipMart Announces Pre-IPO Share Price of Hang Yick Holdings Company Limited (Stock code: 01894)

(Hong Kong – 11 Oct 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Hang Yick Holdings Company Limited (“Hang Yick Holdings”; stock code: 01894) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hang Yick Holdings on PhillipMart were HK\$0.81 and HK\$0.68. The price closed at HK\$0.72 per share, 15.29% lower than its offer price of HK\$0.85. The price opened at HK\$0.68, with the most actively traded price of HK\$0.8 per share, and a turnover of 465,000 shares. The total trading volume reached 2,505,000shares with **total turnover of HK\$1,927,800.00**. The final price of Hang Yick Holdings, to debut trading tomorrow has been fixed at HK\$0.85 per share.
