

**PhillipMart Announces Pre-IPO Share Price of  
 Grand Talents Group Holdings Limited (Stock code: 08516)**

(Hong Kong – 12 Oct 2016 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Grand Talents Group Holdings Limited (“Grand Talents”; stock code: 08516) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Grand Talents on PhillipMart were HK\$0.55 and HK\$0.42. The price closed at HK\$0.53 per share, 32.05% higher than its offer price of HK\$0.4. The price opened at HK\$0.42, with the most actively traded price of HK\$0.45 per share, and a turnover of 590000 shares. The total trading volume reached 5,330,000shares with **total turnover of HK\$2,499,750.00**. The final price of Grand Talents, to debut trading at 15 Oct. It has been fixed at HK\$0.4 per share.
