

## PhillipMart Announces Pre-IPO Share Price of Fameglow Holdings Limited (Stock code: 08603)

(Hong Kong – 12 Oct 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Fameglow Holdings Limited ("Fameglow"; stock code: 08603) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Fameglow on PhillipMart were HK\$0.475 and HK\$0.28. The price closed at HK\$0.385 per share, 37.5% higher than its offer price of HK\$0.28. The price opened at HK\$0.28, with the most actively traded price of HK\$0.42 per share, and a turnover of 2,970,000 shares. The total trading volume reached 20,100,000shares with **total turnover of HK\$7,696,600**. The final price of Fameglow, to debut trading at 15 Oct. It has been fixed at HK\$0.28 per share.
