PhillipMart Announces Pre-IPO Share Price of SHING CHI HOLDINGS LIMITED (Stock code: 1741)

(Hong Kong – 15 Oct2018) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of SHING CHI HOLDINGS LIMITED ("SHING CHI HLDGS"; stock code: 1741) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SHING CHI HLDGS on PhillipMart were HK\$0.66 and 0.53. The price closed at HK\$0.62 per share, 0.8% lower than its offer price of HK\$0.625. The price opened at HK\$0.65, with the most actively traded price of HK\$0.64 per share, and a turnover of 32,740,000 shares. The total trading volume reached 42,264,000 shares with total turnover of 26,727,160.00. The final price of SHING CHI HLDGS, to debut trading tomorrow has been fixed at HK\$0.625 per share.
