

PhillipMart Announces Pre-IPO Share Price of MOS House Group Limited (Stock code: 1653)

(Hong Kong – 18 Oct2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of MOS House Group Limited ("MOS House"; stock code: 1653) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for MOS House on PhillipMart were HK\$0.32 and 0.21. The price closed at HK\$0.315 per share, 65.79% higher than its offer price of HK\$0.19. The price opened at HK\$0.21, with the most actively traded price of HK\$0.25 per share, and a turnover of 4,165,000 shares. The total trading volume reached 63,060,000 shares with **total turnover of HK\$16,715,160.00**. The final price of MOS House, to debut trading tomorrow has been fixed at HK\$0.19 per share.
