

PhillipMart Announces Pre-IPO Share Price of Innovent Biologics, Inc. (Stock code: 1801)

(Hong Kong – 30 Oct 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Innovent Biologics, Inc. ("Innovent Bio"; stock code: 1801) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Innovent Bio on PhillipMart were HK\$14.1 and 13.6. The price closed at HK\$14.1 per share, 0.86% higer than its offer price of HK\$13.98. The price opened at HK\$13.7, with the most actively traded price of HK\$13.98 per share, and a turnover of 1,777,500 shares. The total trading volume reached 4,976,000 shares with **total turnover of HK\$68,955,740.00**. The final price of Innovent Bio, to debut trading tomorrow has been fixed at HK\$13.98 per share.
