

**PhillipMart Announces Pre-IPO Share Price of  
 Dragon Mining Limited (Stock code: 1712)**

(Hong Kong – 2 Nov 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Dragon Mining Limited (“Dragon Mining”; stock code: 1712) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Dragon Mining on PhillipMart were HK\$2.4 and 2.05. The price closed at HK\$2.2 per share, 8.37% higher than its offer price of HK\$2.03. The price opened at HK\$2.18, with the most actively traded price of HK\$2.21 per share, and a turnover of 225,000 shares. The total trading volume reached 1,608,000 shares with **total turnover of HK\$3,527,300.00**. The final price of Dragon Mining, to debut trading at 5 Nov. It has been fixed at HK\$2.03 per share.
