

PhillipMart Announces Pre-IPO Share Price of Tongcheng-Elong Holdings Limited (Stock code: 780)

(Hong Kong – 23 Nov 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tongcheng-Elong Holdings Limited ("Tongcheng-Elong"; stock code: 780) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tongcheng-Elong on PhillipMart were HK\$11.46 and HK\$10. The price closed at HK\$11.34 per share, 15.71% higher lower than its offer price of HK\$9.8. The price opened at HK\$10, with the most actively traded price of HK\$10.2 per share, and a turnover of 251,600 shares. The total trading volume reached 3,114,000 shares with **total turnover of HK\$33,047,024.00**. The final price of Tongcheng-Elong, to debut trading at 26 Nov 2018. It has been fixed at HK\$9.8 per share.
