

PhillipMart Announces Pre-IPO Share Price of BabyTree Group (Stock code: 1761)

(Hong Kong – 26 Nov 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of BabyTree Group ("BabyTree"; stock code: 1761) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for BabyTree on PhillipMart were HK\$7.78 and HK\$7.02. The price closed at HK\$7.18 per share, 5.59% higher than its offer price of HK\$6.8. The price opened at HK\$7.02, with the most actively traded price of HK\$7.14 per share, and a turnover of 244,000 shares. The total trading volume reached 2,328,500shares with **total turnover of HK\$16,864,790.00**. The final price of BabyTree, to debut trading at 27 Nov. It has been fixed at HK\$6.8 per share.
