

**PhillipMart Announces Pre-IPO Share Price of  
 iDreamSky Technology Holdings Limited (Stock code: 1119)**

(Hong Kong – 5 Dec 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of iDreamSky Technology Holdings Limited (“iDreamSky”; stock code: 1119) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for iDreamSky on PhillipMart were HK\$7.3 and HK\$6.86. The price closed at HK\$6.88 per share, 4.24% higher than its offer price of HK\$6.6. The price opened at HK\$7, with the most actively traded price of HK\$6.9 per share, and a turnover of 747,200 shares. The total trading volume reached 4,586,400shares with **total turnover of HK\$31,893,684.00**. The final price of iDreamSky , to debut trading at 6 Dec. It has been fixed at HK\$6.6 per share.
