

**PhillipMart Announces Pre-IPO Share Price of
 Mobvista Inc. (Stock code: 1860)**

(Hong Kong – 11 Dec 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Mobvista Inc. (“Mobvista”; stock code: 1860) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Mobvista on PhillipMart were HK\$3.83 and HK\$3.2. The price closed at HK\$3.72 per share, 7% lower than its offer price of HK\$4. The price opened at HK\$3.2, with the most actively traded price of HK\$3.5 per share, and a turnover of 657,000 shares. The total trading volume reached 4,081,000 shares with **total turnover of HK\$14,459,840.00**. The final price of Mobvista, to debut trading tomorrow has been fixed at HK\$4 per share.
