

**PhillipMart Announces Pre-IPO Share Price of  
 Fosun Tourism Group (Stock code: 1992)**

(Hong Kong – 13 Dec 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Fosun Tourism Group (“Fosun Tourism”; stock code: 1992) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Fosun Tourism on PhillipMart were HK\$15.6 and HK\$15.02. The price closed at HK\$15.6 per share, same as its offer price of HK\$15.6. The price opened at HK\$15.52, with the most actively traded price of HK\$15.58 per share, and a turnover of 69,600 shares. The total trading volume reached 358,400shares with **total turnover of HK\$5,509,720**. The final price of Fosun Tourism, to debut trading tomorrow has been fixed at HK\$15.6 per share.
