

## PhillipMart Announces Pre-IPO Share Price of AsiaInfo Technologies Limited (Stock code: 1675)

(Hong Kong – 18 Dec 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of AsiaInfo Technologies Limited ("AsiaInfo Tech"; stock code: 1675) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for AsiaInfo Tech on PhillipMart were HK\$10.54 and HK\$10.3. The price closed at HK\$10.38 per share, 1.14% lower than its offer price of HK\$10.5. The price opened at HK\$10.5, with the most actively traded price of HK\$10.3 per share, and a turnover of 44,400 shares. The total trading volume reached 178,800shares with **total turnover of HK\$1,851,296**. The final price of AsiaInfo Tech, to debut trading tomorrow has been fixed at HK\$10.5 per share.
