

**PhillipMart Announces Pre-IPO Share Price of
 WANKA ONLINE INC. (Stock code: 1762)**

(Hong Kong – 20 Dec 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of WANKA ONLINE INC. (“WANKA ONLINE”; stock code: 1762) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for WANKA ONLINE on PhillipMart were HK\$3.86 and HK\$3.5. The price closed at HK\$3.79 per share, 6.46% higher than its offer price of HK\$3.56. The price opened at HK\$3.56, with the most actively traded price of HK\$3.8 per share, and a turnover of 313,000 shares. The total trading volume reached 1,093,000shares with **total turnover of HK\$4,072,880**. The final price of WANKA ONLINE, to debut trading tomorrow has been fixed at HK\$3.56 per share.
