

**PhillipMart Announces Pre-IPO Share Price of  
 Sichuan Energy Investment Development Co., Ltd. (Stock code: 1713)**

(Hong Kong – 27 Dec 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Sichuan Energy Investment Development Co., Ltd. (“Sichuan En Inv”; stock code: 1713) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Sichuan En Inv on PhillipMart were HK\$1.77 and HK\$1.7. The price closed at HK\$1.77 per share, it is same as offer price. The price opened at HK\$1.77, with the most actively traded price of HK\$1.77 per share, and a turnover of 162,000 shares. The total trading volume reached 378,000shares with **total turnover of HK\$661,720**. The final price of Sichuan En Inv, to debut trading tomorrow has been fixed at HK\$1.77 per share.
