

## PhillipMart Announces Pre-IPO Share Price of TS Wonders Holding Limited (Stock code: 1767)

(Hong Kong – 11 Jan 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of TS Wonders Holding Limited ("TS Wonders"; stock code: 1767) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for TS Wonders on PhillipMart were HK\$0.67 and HK\$0.57. The price closed at HK\$0.61 per share, 22% higher than its offer price of HK\$0.5. The price opened at HK\$0.6, with the most actively traded price of HK\$0.62 per share, and a turnover of 3,210,000 shares. The total trading volume reached 10,715,500 shares with **total turnover of HK\$17,290,000**. The final price of TS Wonders, to debut trading at 14 Jan. It has been fixed at HK\$0.5 per share.

In view of customers demand, Phillip Securities announce that the trading hours of PhillipMart has be changed from 4:30p.m. - 6:00p.m. to 4:15p.m.-6:30p.m. effective from Thursday, 29 March 2012.
