

PhillipMart Announces Pre-IPO Share Price of WEIMOB INC. (Stock code: 2013)

(Hong Kong – 14 Jan 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of WEIMOB INC. (“WEIMOB INC.”; stock code:2013) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for WEIMOB INC. on PhillipMart were HK\$3.2 and HK\$2.6. The price closed at HK\$3.2 per share, 14.29% higher than its offer price of HK\$2.8. The price opened at HK\$2.6, with the most actively traded price of HK\$2.95 per share, and a turnover of 1,066,000 shares. The total trading volume reached 6,682,000shares with **total turnover of HK\$19,789,850.00**. The final price of WEIMOB INC., to debut trading tomorrow has been fixed at HK\$2.8 per share.
