## **PhillipMart Announces Pre-IPO Share Price of** China Kepei Education Group Limited (Stock code: 1890)

(Hong Kong – 24 Jan 2019) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Kepei Education Group Limited ("China Kepei"; stock code: 1890) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Kepei on PhillipMart were HK\$2.49 and HK\$2.38. The price closed at HK\$2.49 per share, 0.4% higher than its offer price of HK\$2.48. The price opened at HK\$2.44, with the most actively traded price of HK\$2.48 per share, and a turnover of 2,468,000 shares. The total trading volume reached 4,272,000shares with total turnover of HK\$10,569,660. The final price of China Kepei, to debut trading tomorrow has been fixed at HK\$2.48 per share.
