

**PhillipMart Announces Pre-IPO Share Price of  
 Dexin China Holdings Company Limited (Stock code: 2019)**

(Hong Kong – 25 Feb 2019 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Dexin China Holdings Company Limited (“Dexin China”; stock code: 2019) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Dexin China on PhillipMart were HK\$2.8 and HK\$2.71. The price closed at HK\$2.75 per share, 1.79% lower than its offer price of HK\$2.8. The price opened at HK\$2.8, with the most actively traded price of HK\$2.73 per share, and a turnover of 91,000 shares. The total trading volume reached 405,000shares with **total turnover of HK\$1,108,640**. The final price of Dexin China, to debut trading tomorrow has been fixed at HK\$2.8 per share.
