PhillipMart Announces Pre-IPO Share Price of WECON HOLDINGS LIMITED (Stock code: 1793)

(Hong Kong – 26 Feb 2019) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of WECON HOLDINGS LIMITED ("WECON HOLDINGS"; stock code: 1793) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for WECON HOLDINGS on PhillipMart were HK\$0.66 and HK\$0.56. The price closed at HK\$0.58 per share, 7.2% lower than its offer price of HK\$0.625. The price opened at HK\$0.65, with the most actively traded price of HK\$0.57 per share, and a turnover of 2,488,000 shares. The total trading volume reached 12,472,000shares with total turnover of HK\$7,451,520. The final price of WECON HOLDINGS, to debut trading tomorrow has been fixed at HK\$0.625 per share.
