

**PhillipMart Announces Pre-IPO Share Price of  
 Guan Chao Holdings Limited (Stock code: 01872)**

(Hong Kong – 27 Feb 2019 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Guan Chao Holdings Limited (“Guan Chao”; stock code: 01872) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Guan Chao on PhillipMart were HK\$0.52 and HK\$0.43. The price closed at HK\$0.51 per share, 18.6% higher than its offer price of HK\$0.43. The price opened at HK\$0.43, with the most actively traded price of HK\$0.495 per share, and a turnover of 15,515,000 shares. The total trading volume reached 61,490,000shares with **total turnover of HK\$30,444,750**. The final price of Guan Chao, to debut trading tomorrow has been fixed at HK\$0.43 per share.
