

PhillipMart Announces Pre-IPO Share Price of K2 F&B HOLDINGS LIMITED (Stock code: 2108)

(Hong Kong – 5 Mar 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of K2 F&B HOLDINGS LIMITED ("K2 FB"; stock code: 2108) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for K2 FB on PhillipMart were HK\$0.9 and HK\$0.78. The price closed at HK\$0.83 per share, 10.67% higher than its offer price of HK\$0.83. The price opened at HK\$0.78, with the most actively traded price of HK\$0.83 per share, and a turnover of 4,432,000 shares. The total trading volume reached 18,996,000shares with **total turnover of HK\$16,092,640**. The final price of K2 FB, to debut trading tomorrow has been fixed at HK\$0.83 per share.
