

**PhillipMart Announces Pre-IPO Share Price of  
 Heng Hup Holdings Limited (Stock code: 1891)**

(Hong Kong – 14 Mar 2019 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Heng Hup Holdings Limited (“Heng Hup”; stock code: 1891) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Heng Hup on PhillipMart were HK\$0.6 and HK\$0.46. The price closed at HK\$0.465 per share, 7% lower than its offer price of HK\$0.5. The price opened at HK\$0.59, with the most actively traded price of HK\$0.54 per share, and a turnover of 9,276,000 shares. The total trading volume reached 46,160,000shares with **total turnover of HK\$23,519,680**. The final price of Heng Hup, to debut trading tomorrow has been fixed at HK\$0.5 per share.
