

PhillipMart Announces Pre-IPO Share Price of China Risun Group Limited (Stock code: 1907)

(Hong Kong – 14 Mar 2019) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Risun Group Limited ("China Risun Gp"; stock code: 1907) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Risun Gp on PhillipMart were HK\$2.82 and HK\$2.73. The price closed at HK\$2.81 per share, 0.36% higher than its offer price of HK\$2.8. The price opened at HK\$2.75, with the most actively traded price of HK\$2.75 per share, and a turnover of 220,000 shares. The total trading volume reached 653,000shares with **total turnover of HK\$1,806,490**. The final price of China Risun Gp, to debut trading tomorrow has been fixed at HK\$2.8 per share.
