

## PhillipMart Announces Pre-IPO Share Price of Binjiang Service Group Co. Ltd. (Stock code: 3316)

(Hong Kong – 14 Mar 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Binjiang Service Group Co. Ltd. ("Binjiang Ser"; stock code: 3316) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Binjiang Ser on PhillipMart were HK\$6.96 and HK\$6.81. The price closed at HK\$6.89 per share, 1.01% lower than its offer price of HK\$6.96. The price opened at HK\$6.95, with the most actively traded price of HK\$6.86 per share, and a turnover of 25,500 shares. The total trading volume reached 126,500shares with **total turnover of HK\$869,055.00**. The final price of Binjiang Ser, to debut trading tomorrow has been fixed at HK\$6.96 per share.
