

PhillipMart Announces Pre-IPO Share Price of Yun Lee Marine Group Holdings Limited (Stock code: 02682)

(Hong Kong – 15 Mar 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Yun Lee Marine Group Holdings Limited (“Yun Lee Marine”; stock code: 02682) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Yun Lee Marine on PhillipMart were HK\$0.5 and HK\$0.345. The price closed at HK\$0.37 per share, 26% lower than its offer price of HK\$0.5. The price opened at HK\$0.5, with the most actively traded price of HK\$0.38 per share, and a turnover of 2,088,000 shares. The total trading volume reached 14,956,000 shares with **total turnover of HK\$5,625,260**. The final price of Yun Lee Marine, to debut trading at 18 Mar, 2019. It has been fixed at HK\$0.5 per share.
