

PhillipMart Announces Pre-IPO Share Price of CanSino Biologics Inc. (Stock code: 6185)

(Hong Kong – 27 Mar 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of CanSino Biologics Inc. ("CanSino"; stock code: 6185) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CanSino on PhillipMart were HK\$29.5 and HK\$23.2. The price closed at HK\$29.4 per share, 33.64% higher than its offer price of HK\$22. The price opened at HK\$23.3, with the most actively traded price of HK\$28 per share, and a turnover of 461,200 shares. The total trading volume reached 4,080,800shares with **total turnover of HK\$113,869,540**. The final price of CanSino, to debut trading tomorrow has been fixed at HK\$22 per share.
