

## PhillipMart Announces Pre-IPO Share Price of Shanghai Dongzheng Automotive Finance Co., Ltd. (Stock code: 02718)

(Hong Kong – 2 Apr 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Shanghai Dongzheng Automotive Finance Co., Ltd.

("Dongzheng AFC"; stock code: 02718) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Dongzheng AFC on PhillipMart were HK\$3.3 and HK\$2.99. The price closed at HK\$3.02 per share, 1.31% lower than its offer price of HK\$3.06. The price opened at HK\$3.08, with the most actively traded price of HK\$3.01 per share, and a turnover of 90,000 shares. The total trading volume reached 1,764,000shares with **total turnover of HK\$5,400,640.00**. The final price of Dongzheng AFC, to debut trading tomorrow has been fixed at HK\$3.06 per share.
