

**PhillipMart Announces Pre-IPO Share Price of  
 Shenwan Hongyuan Group Co., Ltd. (Stock code: 6806)**

(Hong Kong – 25 Apr 2019 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Shenwan Hongyuan Group Co., Ltd. (“SWHY”; stock code: 6806) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SWHY on PhillipMart were HK\$3.63 and HK\$3.51. The price closed at HK\$3.57 per share, 1.65% lower than its offer price of HK\$3.63. The price opened at HK\$3.63, with the most actively traded price of HK\$3.55 per share, and a turnover of 2,528,000 shares. The total trading volume reached 7,350,400shares with **total turnover of HK\$26,219,496**. The final price of SWHY, to debut trading tomorrow has been fixed at HK\$3.63 per share.
