

## PhillipMart Announces Pre-IPO Share Price of B & D Strategic Holdings Limited (Stock code: 01780)

(Hong Kong – 29 Apr 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of B & D Strategic Holdings Limited ("B & D Strategic"; stock code: 01780) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for B & D Strategic on PhillipMart were HK\$0.91 and HK\$0.76. The price closed at HK\$0.77 per share, 8.33% lower than its offer price of HK\$0.84. The price opened at HK\$0.84, with the most actively traded price of HK\$0.78 per share, and a turnover of 1,350,000 shares. The total trading volume reached 3,590,000 shares with **total turnover of HK\$2,836,575**. The final price of B & D Strategic, to debut trading tomorrow has been fixed at HK\$0.84 per share.
