

PhillipMart Announces Pre-IPO Share Price of China Everbright Water Limited (Stock code: 01857)

(Hong Kong – 7 May 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Everbright Water Limited ("CEB Water"; stock code: 01857) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CEB Water on PhillipMart were HK\$3 and HK\$2.94. The price closed at HK\$2.96 per share, 1% lower than its offer price of HK\$2.99. The price opened at HK\$2.99, with the most actively traded price of HK\$2.96 per share, and a turnover of 87,000 shares. The total trading volume reached 219,000shares with **total turnover of HK\$649,490.00**. The final price of CEB Water, to debut trading tomorrow has been fixed at HK\$2.99 per share.
