

PhillipMart Announces Pre-IPO Share Price of JBB Builders International Limited (Stock code: 01903)

(Hong Kong – 9 May 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of JBB Builders International Limited ("JBB Builders"; stock code: 01903) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for JBB Builders on PhillipMart were HK\$1.05 and HK\$0.88. The price closed at HK\$0.88 per share, 25.42% lower than its offer price of HK\$1.18. The price opened at HK\$1.05, with the most actively traded price of HK\$0.9 per share, and a turnover of 918,000 shares. The total trading volume reached 3,076,000shares with **total turnover of HK\$2,830,220**. The final price of JBB Builders, to debut trading tomorrow has been fixed at HK\$1.18 per share.
