

PhillipMart Announces Pre-IPO Share Price of Universal Star (Holdings) Limited (Stock code: 02346)

(Hong Kong – 15 May 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Universal Star (Holdings) Limited ("Universal Star"; stock code: 02346) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Universal Star on PhillipMart were HK\$1.16 and HK\$1. The price closed at HK\$1.08 per share, 8% higher than its offer price of HK\$1. The price opened at HK\$1, with the most actively traded price of HK\$1.1 per share, and a turnover of 856,000 shares. The total trading volume reached 5,026,000 shares with **total turnover of HK\$5,569,260**. The final price of Universal Star, to debut trading tomorrow has been fixed at HK\$1 per share.
