

PhillipMart Announces Pre-IPO Share Price of Medialink Group Limited (Stock code: 02230)

(Hong Kong – 20 May 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Medialink Group Limited ("Medialink Group"; stock code: 02230) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Medialink Group on PhillipMart were HK\$0.48 and HK\$0.405. The price closed at HK\$0.41 per share, 8.89% lower than its offer price of HK\$0.45. The price opened at HK\$0.46, with the most actively traded price of HK\$0.43 per share, and a turnover of 3,725,000 shares. The total trading volume reached 16,900,000shares with **total turnover of HK\$7,372,375**. The final price of Medialink Group, to debut trading tomorrow has been fixed at HK\$0.45 per share.
