

## PhillipMart Announces Pre-IPO Share Price of Xinyi Energy Holdings Limited (Stock code: 03868)

(Hong Kong – 27 May 2019 ) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Xinyi Energy Holdings Limited ("Xinyi Energy"; stock code: 03868) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Xinyi Energy on PhillipMart were HK\$1.97 and HK\$1.86. The price closed at HK\$1.97 per share, 1.55% than its offer price of HK\$1.94. The price opened at HK\$1.9, with the most actively traded price of HK\$1.97 per share, and a turnover of 680,000 shares. The total trading volume reached 2,078,000 shares with **total turnover of HK\$4,054,760**. The final price of Xinyi Energy, to debut trading tomorrow has been fixed at HK\$1.94 per share.
