

PhillipMart Announces Pre-IPO Share Price of Tai Hing Group Holdings Limited (Stock code: 06811)

(Hong Kong – 12 June 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tai Hing Group Holdings Limited ("Tai Hing Group"; stock code: 06811) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tai Hing Group on PhillipMart were HK\$3.03 and HK\$2.75. The price closed at HK\$2.81 per share, 6.33% lower than its offer price of HK\$3. The price opened at HK\$3.03, with the most actively traded price of HK\$2.9 per share, and a turnover of 1,036,000 shares. The total trading volume reached 9,645,000 shares with **total turnover of HK\$27,741,780**. The final price of Tai Hing Group, to debut trading tomorrow has been fixed at HK\$3 per share.
