

**PhillipMart Announces Pre-IPO Share Price of
 Hansoh Pharmaceutical Group Company Limited (Stock code: 3692)**

(Hong Kong – 13 June 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Hansoh Pharmaceutical Group Company Limited (“Hansoh Pharma”; stock code: 3692) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hansoh Pharma on PhillipMart were HK\$16.12 and HK\$14.52. The price closed at HK\$16.02 per share, 12.34% higher than its offer price of HK\$14.26. The price opened at HK\$14.52, with the most actively traded price of HK\$15.2 per share, and a turnover of 1,226,000 shares. The total trading volume reached 8,998,000 shares with **total turnover of HK\$138,772,520**. The final price of Hansoh Pharma, to debut trading tomorrow has been fixed at HK\$14.26 per share.
